

TERMS AND CONDITIONS FOR APPLICANTS TO ENROLL IN THE PROGRAM

Program Overview

The project aims to offer Recognition of Prior Learning (RPL) training to voice-over artists, enhancing their skills and opening up new industry opportunities. Selected participants may also work on joint projects such as "Azaadi ki Amrit Kahaniya," narrating stories that celebrate India's innovative spirit.

Workshop Duration

6 days per location, covering 2 or more states per month.

Selection Process

- ▶ **Number of Applications:** 250 applications will be called.
- ▶ **Selection Process:** 210 Candidates will be selected via a preliminary round of Jury appointed for shortlisting of the candidates. (Women candidates will be given preference)
- ▶ **Course Duration:** 5 days of coursework (6 hours daily) plus an assessment on the sixth day.
- ▶ **Eligibility Criteria:** Candidates having more than 2 years of experience in the media and entertainment sector, and willing to upskill will be preferred.

Recognition of Prior Learning (RPL) & Bridge Learning Programs

The proposed program, "The Voicebox," will be conducted in India in 2024 for voice-over artists.

RULES & REGULATIONS

Application Process

- ▶ Submission of the application form does not guarantee selection; the final decision depends on the results of the Online Creative Aptitude Test.
- ▶ Application fee: ₹1180, inclusive of taxes.

Program Details

- ▶ Tentative commencement date: 5th August 2024.
- ▶ Duration: 5-day workshop followed by an assessment on the 6th day.
- ▶ Coursework: 30 hours of theory and practical sessions.
- ▶ Eligibility: Open only to individuals from New Delhi, Mumbai, Kolkata, Ahmedabad, Hyderabad, Chennai, and Kochi.
- ▶ Attendance: Minimum 90% attendance required for certification.
- ▶ Punctuality: Students must be punctual for the workshop

Financial Responsibilities

- ▶ Candidates are responsible for their travel costs.
- ▶ Other than training delivery and certifications, no costs will be covered by the institution.

Assessment & Certification

- ▶ Assessments will be conducted by NFDC, followed by joint certifications from NFDC, Netflix, and the training institution.
- ▶ Selected voices from each state will be further evaluated, and one shortlisted voice will get an opportunity to work on the Netflix project "Azaadi ki Amrit Kahaniya".
